



Currently, there are 24 indicators that need to be reported on by Health Services as part of six-monthly nKPI reporting. This reporting is currently conducted through the Health Data Portal.

The table below details each of the nKPIs that need to be completed by Health Services when submitting their nKPI report.

PI01	Birth weight recorded	Number and proportion of Indigenous babies born within the previous 12 months whose birth weight has been recorded at the primary health care service.
PI02	Birth weight result	Number and proportion of Indigenous babies born within the previous 12 months whose birth weight results were categorised as one of the following: <ul style="list-style-type: none">• Low (less than 2,500 grams)• Normal (2,500 grams to less than 4,500 grams)• High (4,500 grams and over).
PI03	Health assessments	Number and proportion of regular clients who are Indigenous, aged 0 - 14 years and for whom a Health Assessment for Aboriginal and Torres Strait Islander People was claimed (both through Telehealth and In Person) within the previous 12 months AND number and proportion of regular clients who are Indigenous, aged 15 years and over and for whom a Health Assessment for Aboriginal and Torres Strait Islander People was claimed (both through Telehealth and In Person) within the previous 24 months.
PI04	Child immunisation	Number and proportion of Indigenous children who are regular clients, aged: <ul style="list-style-type: none">• 12 months to less than 24 months;• 24 months to less than 36 months;• 60 months to less than 72 months; and who are 'fully immunised'.
PI05	HbA1c recorded	Number and proportion of regular clients who are Indigenous, have Type II diabetes and who have had an HbA1c measurement result recorded at the primary health care service within the previous six months AND number and proportion of regular clients who are Indigenous, have Type II diabetes and who have had an HbA1c measurement result recorded at the primary health care service within the previous 12 months.
PI06	HbA1c result	Number and proportion of regular clients who are Indigenous, have Type II diabetes and whose HbA1c measurement result, recorded within either the previous six months or 12 months, was categorised as one of the following:

The data previously captured through this indicator has proved to be very similar to that captured through PI07, so PI08 is no longer needed.</p>
PI09	Smoking status recorded	Number and proportion of regular clients who are Indigenous, aged 15 years and over and whose smoking status has been recorded at the primary health care service.
PI10	Smoking status result	<p>Number and proportion of regular clients who are Indigenous, aged 15 years and over and whose smoking status has been recorded as one of the following:</p> <ul style="list-style-type: none">current smoker,ex-smoker, ornever smoked.
PI11	Smoking status result of women who gave birth	<p>Number and proportion of regular clients who are Indigenous, aged 15 years and over, who gave birth within the previous 12 months and whose smoking status has been recorded as one of the following:</p> <ul style="list-style-type: none">current smoker,ex-smoker, ornever smoked.
PI12	Body Mass Index	Number and proportion of regular clients who are Indigenous, aged 25 years and over and who have had their BMI classified as overweight or obese within the previous 24 months.

PI18	Kidney function test recorded	Number and proportion of regular clients who are Indigenous, aged 15 years and over who are recorded as having Type II diabetes and have had an estimated glomerular filtration rate (eGFR) recorded AND/OR an albumin/creatinine ratio (ACR) or other micro albumin test result recorded within the previous 12 months. Number and proportion of regular clients who are Indigenous, aged 15 years and over who are recorded as having cardiovascular disease (CVD) and have had an eGFR recorded within the previous 12 months.
PI19A	eGFR result	Number and proportion of regular clients who are Indigenous, aged 15 years and over, are recorded as having Type II diabetes or cardiovascular disease (CVD) and who have had an estimated glomerular filtration rate (eGFR) recorded within the previous 12 months with a result of (ml/min/1.73m ²): <ul style="list-style-type: none">• greater than or equal to 90;• greater than or equal to 60 but less than 90;• greater than or equal to 45 but less than 60;• greater than or equal to 30 but less than 45;

PI13	First antenatal care visit	Number and proportion of regular clients who are Indigenous, who gave birth within the previous 12 months and who had gestational age recorded at their first antenatal care visit with results either: <ul style="list-style-type: none">• less than 13/40 weeks;• 13/40 weeks to less than 20/40 weeks;• at or after 20/40 weeks or;• no result.
